2. The complete booking form must be emailed to: arasc_penang.usm.my
3. ARASC will only process a complete booking form.
4. Payment must be made based on the quotation provided by ARASC prior to the service date. Failure to do so will result in the application being cancelled.
5. ARASC will disclose the application results via email.
6. The transportation of animals will only be done in the morning. This is to avoid heat stress on animals.
7. Applicants are not allowed to share the service of this vehicle with other individuals /users who intended to carry laboratory animals or other supplies during the service. If the applicant is found to be in violation of these terms and conditions, we reserve the right to revoke the application and cancel the service. This will also further affect the future application.
